- FinTech Financing activity in July leveled out after June's record breaking \$17 billion in financing volume, but still stayed above the median monthly volume for the year (\$3.5 billion). July had the highest number of \$25 million+ financings so far this year (32 transactions) with 10 of these financings occurring in the Banking / Lending Tech sector.
- M&A activity was fairly steady this month, dropping below the median monthly volume of \$9.1 billion, but staying above the median monthly number of transactions (67). The two largest transactions (acquisitions of Charles River Development and Eze Software) were both in the Capital Markets / WealthTech sector.
- FT Partners' recent deals include MarketInvoice's strategic financing & partnership with Barclays, ING's €21 million investment in TransferMate, Equidate's \$50 million Series B financing, PPRO's \$50 million financing led by PayPal, Moneybox's £14 million Series B financing, Next Insurance's \$83 million Series B financing, and GPS' £44 million financing led by Dunedin.


